### **Key Features**

This is a Euro denominated fund which invests primarily in European equities and provides the Client with the means of gaining exposure to the potential upside of equity markets over the medium term. The investment manager selects undervalued themes highlighted by a top-down quantitative secular analysis which then focuses on a single company and its future economic prospects, emphasizing European companies with business activities in foreign markets. The portfolio is carefully constructed piecemeal through a rigorous top-down analysis of future demographic trends and socioeconomic-healthcare developments.



# **Investment Policy**

The selection of the investment opportunities begins with the analysis of International Organisations' guidelines (FMI, OCSE, ONU, FAO, etc.) concerning the development of secular trends. Among the main themes: poverty reduction, prosperity promotion and protection of the environment. Furthermore, industries which better interpret secular trends are identified and, finally, the stock picking of European listed companies that can benefit from mega trends takes place. Guidelines for the investment:

- ✓ Companies listed in Europe (0 100% of AuM)
- ✓ Stocks selected outside European markets(0 10% degli AuM)
- ✓ Derivative instruments admitted (long-short) for an efficient portfolio management




## **Portfolio**
