Objectives and Investment Policy	
The Fund aims to achieve a positive return over the medium term by investing in a wide range of debt securities mainly of Euro currency and listed on a Regulated Market (as set out in the Prospectus) and may also invest in equities (shares and related securities).	The credit rating agencies currently approved for such purposes are Standard and Poor's, Moody's, Fitch and DBRS. The Fund may also hold ancillary liquid assets such as time deposits (a
The Fund is actively managed and is not managed in reference to a benchmark. The Investment Manager has discretion over the composition of the Fund's portfolio, subject to the stated investment objectives and policies. Investments could include fixed income and debt securities, such as bonds, senior notes (debt that takes priority over unsecured or more junior debt), subordinated debt (debt that ranks below other debt with regard to claim on assets or earnings), structured notes (a type of hybrid debt security which usually has a derivative component), certificates of deposit, medium term loan notes, asset and mortgage backed securities, collateralised debt and other debt instruments. These investments will mainly be issued or guaranteed by any OECD government and/or by corporate or other issuers like special purpose vehicles. The Fund may invest up to 10% of its net asset value (NAV) directly or in directly in global equity securities across a range of industries mainly through investing in convertible bonds (securities that give the holder the right to buy newly created shares at a fixed price during a set period).
