Fund strategy

The Tendercapital Secular Euro fund is an actively managed long-only thematic fund with a long-term return objective. The strategy is defined by the selection of European companies operating in the "Robotics & Automation", "Sustainable Environment', 'Digital Economy' and 'Healthy Living' segments. The fund promotes environmental, social and governance (ESG) traits through a combination of exclusion, ESG integration and active management.

Active responsible investment

The fund incorporates ESG aspects into investment decisions by quantifying their impact on the company. The investment strategy is based on active security selection and thus focuses on ESG risks that are relevant for each individual company.

Investment themes

Secular trends are long-term changes in the economic and social environment that can redefine corporate operating models. Identifying, analysing and operating in accordance with secular trends is essential for a successful strategy. They align the investment process with irreversible structural changes in the world around us and offer a long-term investment perspective.

Our thematic approach has selected four major investment themes that form the basis of the fund's strategy for selecting individual portfolio companies.

Secular trends represent long-term investment opportunities that are less sensitive to the business cycle

2- Active ownership

Active management allows a flexible and multi-thematic approach

3- Sustainability commitment

Robotics & Automation

The 'Robotics & Automation' theme selects companies that offer innovative solutions to improve productivity and the execution of critical tasks in industrial environments and consumer applications. The analysis focuses on industrial robots, service robots and artificial intelligence.



Healthy Living

The 'Healthy Living' theme selects companies active in the wellness industry that promote products and services related to healthy and full individual fulfilment.



Sustainable environment

The 'Sustainable Environment' theme selects companies whose activities promote longterm sustainable development. The theme focuses on seven sustainable goals (SDGs) organised in two different categories: reducing pollution and protecting resources.



Digital economy

The theme 'Digital Economy' selects companies active in the digital transition in the segments of e-commerce, fintech, cybersecurity and digital media.



Investment objectives and policy

The fund invests in equity instruments of European issuers operating in the 'Robotics & Automation', 'Sustainable Environment', 'Digital Economy' and "Healthy Living' sectors. The fund promotes environmental, social and governance (ESG) characters through a combination of exclusion, ESG parameter integration and active management. ESG characters are combined with traditional financial analysis to provide the basis for defining the portfolio. The fund is actively managed and aims to outperform the Stoxx Europe 600 return over a medium-term time horizon. Most positions in the portfolio are not necessarily included or weighted in accordance with the relevant benchmark. The manager uses a discretionary approach to define the optimal portfolio allocation with the aim of capturing specific investment opportunities.


